Volume I contains the Social Security Act, as amended, and selected provisions of the Internal Revenue Code (IRC). Volume II contains the appendixes of the Act and provisions of public laws and statutes cited in the Act. It also includes other provisions of the IRC and public laws that affect the administration of the Act but do not amend it. The *Handbook* also contains brief descriptions of related programs administered by other agencies.
