Coverage varies by source.

### Alabama Civil Trial Reporter

AL-CTR-JV

Summaries of jury verdicts and settlements from Alabama state and federal courts, including information such as case type; geographic area where a case was tried or settled; names of parties and attorneys; factual information about the case; and verdict or settlement amount. Coverage begins with 2004.

### Alabama Jury Verdict Reporter

AL-AJVR-JV

Summaries of jury verdicts and settlements from Alabama state and federal courts from the *Alabama Jury Verdict Reporter*, including information such as case type; geographic area where a case was tried or settled; names of parties and attorneys; factual information about the case; and verdict or settlement amount. Coverage begins with 2002.

### California Jury Verdicts All

CA-JV-ALL

Summaries of jury verdicts, judgments, settlements, and arbitration awards from federal and state proceedings in California compiled by various jury verdict publishers, including information such as case type; geographic area where a case was tried; names of parties, attorneys, and expert witnesses; factual information about the case; and verdict or judgment amount. Coverage varies by source.

Coverage begins with 1991.

FLPFL-JV

Summaries of jury verdicts and settlements from Florida state and federal courts supplied by Florida Legal Periodicals Inc., including information such as case type; geographic area where a case was tried or settled; names of parties and attorneys; factual information about the case; and verdict or settlement amount. Coverage begins with 1987.

**Indiana Jury Verdict Reporter**

IN-IJVR-JV

Summaries of jury verdicts and settlements from Indiana state and federal courts from the *Indiana Jury Verdict Reporter*, including information such as case type; geographic area where a case was tried or settled; names of parties and attorneys; factual information about the case; and verdict or settlement amount. Coverage begins with 2000.

JVRSMO-JV

Information on jury verdicts and settlements in Missouri published in the *Jury Verdict Reporting Service*, such as case type; jurisdiction; names of parties, attorneys, and expert witnesses; factual information about the case; and amount of award. Coverage begins with 1984.
