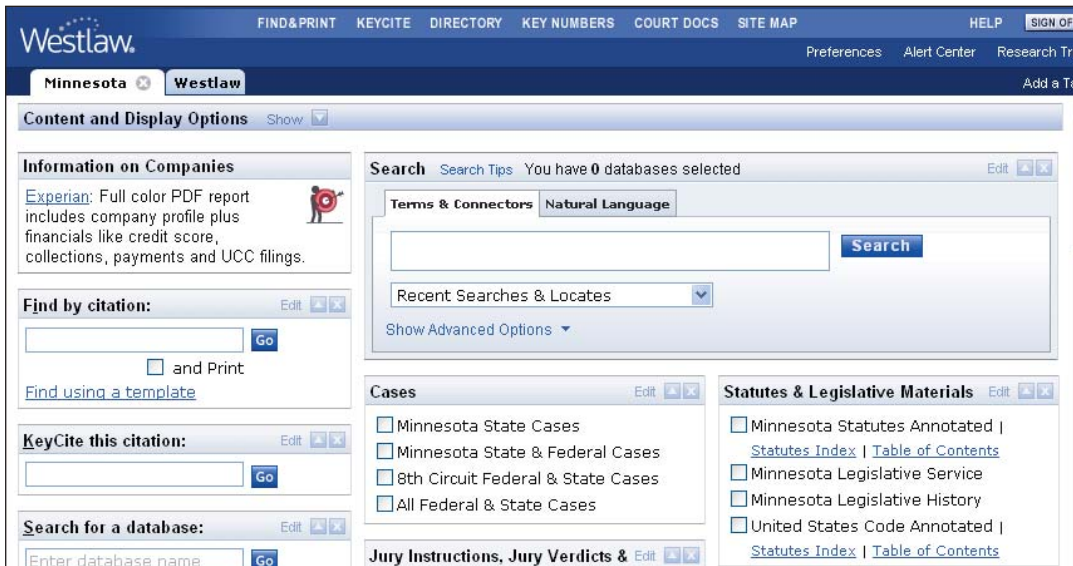


# What's in Your WestlawPRO® Plan

## Using Your Tabbed State Page

Using your state page makes it easy to access the databases in your WestlawPRO plan and helps you use Westlaw more efficiently. You can easily add databases in your plan to your state page.

## Accessing the Databases in Your WestlawPRO plan

Your WestlawPRO plan contains databases that you can search without incurring any hourly or transactional charges. Some of these databases are listed on your tabbed state page. To browse a list of all the databases in your plan, click **Directory** at the top of any page. The Westlaw Directory is displayed. The databases in your WestlawPRO plan are listed in the right frame. Browse the list of databases by clicking the hypertext links. Click a database name to access a database. Click **All Databases** in the left frame to display all Westlaw databases. Click **My Databases** to return to the list of databases in your WestlawPRO plan.

## Identifying Databases Not in Your Plan

You can easily identify the Westlaw databases on your state page that are not included in your WestlawPRO plan by selecting an option that marks each of those databases with an asterisk (\*). To select this option, click **Preferences** at the top of any page. At the Location and Pricing Preferences page, select the **Display an (" \* ") beside databases that are outside of your Westlaw subscription** check box, then click **Save Changes**.
