

## Schedule A to Subscriber Agreement



### WestlawPRO – Campus Research Educational Institution Service for FEDLINK Users

Available only to academic programs at colleges and universities located inside the United States and its territories and possessions. Not available to law schools.

1. **Monthly WestlawPRO Charges.** The monthly WestlawPRO charges ("Monthly WestlawPRO Charges") for the products elected by Subscriber appear on the Order Form and include usage, communications, offline transmission (as limited by the "User Agreement" as defined below), transactional charges (excluding online citation checking as defined below) and certain offline automated citation checking charges. Monthly WestlawPRO Charges apply regardless of Subscriber's actual use. Access to and use of databases, Features and services that are not part of the WestlawPRO products elected by Subscriber shall be blocked. The Monthly WestlawPRO Charges shall be determined by the number of Subscriber's full-time equivalent students ("FTEs"). Subscriber's FTEs shall be based upon the enrollment figures for the fall semester of the prior academic year as provided in writing by Subscriber.
2. **Authorized Use.** Subscriber shall be entitled to unlimited "Authorized Use" (as defined below) of the Campus Research databases elected by Subscriber. Remote access to Campus Research shall not be provided to any alumni of any division, department, school, college or the like of Subscriber nor shall access to Campus Research be provided to any other persons other than Subscriber's faculty, administration and staff ("Personnel") or students ("Subscriber's Users"); provided, however, incidental walk-in access to Campus Research by non-Subscriber's users in Subscriber's library(ies) is permissible. "Authorized Use" shall mean use solely for educational, research and non-commercial purposes by Subscriber's Users and Personnel. Any other use is strictly prohibited. Access by alumni or non-Subscriber's Users may result in termination of access to Campus Research per term and termination terms of the Westlaw Subscriber Agreement.
3. **Passwords.** Access to Campus Research is provided through Subscriber's server and employs transparent authentication. Westlaw passwords will be held at West and shall not be revealed to Subscriber or Subscriber's Users. Subscriber's Users and incidental walk-in users shall be bound by West's Campus Research Terms of Use ("User Agreement") when accessing Campus Research. In no event shall such terms materially differ from the provisions of this Agreement. In the event of any conflict between said User Agreement and the Amendment, the terms of the Amendment shall prevail with regard to Subscriber and personnel.
4. **Responsibility for Certain Matters.** Paragraph 8 of the Subscriber Agreement notwithstanding, Subscriber will exercise reasonable, good faith efforts to enforce any restrictions on the use of Westlaw Data found in the User Agreement between West and each of Subscriber's Users.
5. **Reservation of Rights.** West reserves the right to modify the terms and conditions of this Agreement, from time to time, and the User Agreement under which Subscriber's Users access Campus Research, including, but not limited to, the right to restrict access to certain Westlaw databases, services and Features or to impose usage or other limitations.
6. **Campus Research Restrictions.** Campus Research is not available to law schools, offices of the general counsel of any college or university or any other similarly situated academic programs.
7. **Training.** Basic Westlaw training will be provided at no charge at West Information Centers or via telephone for Subscriber's personnel who will use or instruct others in the use of Campus Research
8. **Subscriber's Security Obligations.** Subscriber agrees to provide its own security to limit access to the Campus Research URL. Subscriber must design, configure and implement its own security configuration.
